City Code § 161-14 is amended to read as follows:

§161-14. Nuisance Declared.

The unnatural presence of pigeons, and other wild animals, including but not limited to raccoons, deer, skunk, opossums, coyotes, birds, squirrels or fox, in the City of Plattsburgh, New York is hereby declared to be a public nuisance, the same being a menace to the health of the community.

City Code § 161-15 is amended to read as follows:

§161-15 Harboring, keeping or feeding pigeons unlawful.

No person, firm, corporation or association shall intentionally feed, harbor or keep any pigeons, and other wild animals, including but not limited to raccoons, deer, skunk, opossums, coyotes, birds, squirrels or fox within the City of Plattsburgh, New York. This section does not apply to bird feeders.


