1. Section C5-3D of the City Charter is amended to read as follows:

“Use of mechanical check-signing facilities is hereby authorized for all payments of city monies to affix or imprint a facsimile signature of the City Chamberlain on checks not exceeding ten thousand dollars (\$10,000) except for payments from trust and agency funds.”
