- 1. Chapter 171 of the City Code of the City of Plattsburgh be and hereby is amended to add a new section which shall read as follows:

Section 171-8.1 Actions by City

When a decision to carry out or approve an action is made by the Common Council or any department, board or agency of the City of Plattsburgh, said Common Council, department, board or agency shall make such determinations as are required to be made under this article and Article 8 of the Environmental Conservation Law, and the regulations promulgated thereunder.


