LOCAL LAW NO. 12 OF 1944.

ENTITLED AN ACT to amend Sections Nos. 1,4,5,7 and 8 of Local Law No. 7 of 1943 by providing for a seven (7%) percent increase in the salaries of certain positions listed under said Sections Nos.1,4,5 and 7, and providing for a five (5%) cent per hour increase in the salaries of skilled, semi-skilled and common laborers listed under said Section No. 8 for the duration of World War No. 2 and for a period of six months

SECTION 1. Effective June 1, 1944 the annual salary attached to the position of "Account Clerk-Stenographer" listed under Section 1 of Local Law No. 7 of 1943 shall be increased by seven (7%) percent, said increase to be regarded as war emergency compensation and to continue in force for the duration of World War No. 2 and for a period of six months thereafter.

SECTION 2. Effective June 1, 1944 the annual salaries attached to the positions of "Junior Stenographer" and "Cleaners" listed under Section 4 of Local Law No. 7 of 1943 shall be increased by seven (7%) percent, said increase to be regarded as war emergency compensation and to continue in force for the duration of World War No. 2 and for a period of six months thereafter.

SECTION 3. Effective June 1,1944 the annual salaries attached to the positions of "Bookkeeper" and "Junior Typist" listed under Section 5 of Local Law No. 7 of 1943, shall be increased by seven (7%) percent, said increase to be regarded as war emergency compensation and to continue in force for the duration of World War No. 2 and for a period of six months thereafter.

SECTION 4. Effective June 1, 1944 the annual salaries attached to the positions of "Tree Surgeon", "Storekeeper", "Auto Mechanic", "Senior Motor Equipment Operator" and "Filter Plant Attendant" listed under Section 7 of Local Law No. 7 of 1943 shall be increased by seven 1780 percent. (7%) percent, said increase to be regarded as war emergency compensation and to continue in force for the duration of World War No. 2 and for a period of six months thereafter.

SECTION 5. Effective June 1, 1944 the hourly rates of pay for the positions of "skilled", "semi-skilled", and "common laborers" listed under Section 8 of Local Law No. 7 of 1943 shall be increased by five (5¢) cents per hour, said increase to be regarded as war emergency compensation and to continue in force for the duration of World War No. 2 and for a period of six months thereafter.

No part of the additional war emergency compensation received under this act shall be regarded as salary or compensation for any of the purposes of any pension or retirement system in which the officer or employee receiving the same is a member, and the receipt of such additional compensation shall not be deemed to change the basic compensation of any such officer or employee for the purpose of computing

a pension, retirement allowance, death benefit, contribution in connection with such membership, or for the purpose of determining any other right or privilege resulting from or appertaining to such memberhip, or for the purpose of determining the right to any increase of salary or any salary increment. No such additional compensation shall be construed to constitute a promotion or to increase any compensation which a public employee may receive pursuant to section two hundred forty-five of the Military Law.

SECTION 7. This Local Law shall take effect as of June 1,1944 after public hearing and approval by the Mayor.

On roll call, Aldermen Gervais, O'Connell, Gioiosa, Demary, Spinks and Tyrell voted in the affirmative; no one in the negative, CARRIED.
