A LOCAL LAW PROVIDING RATES AND REGULATIONS FOR WATER SERVICES AND PROVIDING PROCEDURES FOR THE LEVYING AND COLLECTION OF WATER CHARGES.

BE IT ENACTED by the Mayor and Common Council of the City of Plattsburgh, New York as follows:

SECTION 1: The following rates and regulations for water services and the method of collection and levying of water charges is hereby enacted.

SPECIAL PROVISIONS:

Where bills are rendered on a monthly basis, one-third of the above quantities will be used in computing the charges for the various steps. The terms of payment, for monthly billings are net-fifteen days after date of bill. Gross amount shall be due thereafter.

All those customers who do not have water meters installed in the water service line serving their premises on the effective date of this service classification shall be billed at the rate of \$10.79 per quarter until such time that a water meter has been set in the water service line to their premises. Thereafter, the rates for sewer service above set forth shall apply.

SECTION 2: LAWS REPEALED.

All acts pertaining to water rates and regulations and all other schedules of water rates and regulations heretofore adopted and inconsistent in whole or in part with this act is hereby repealed.

SECTION 3: TIME OF TAKING EFFECT.

This act shall take effect for water bills rendered on and after November 15, 1978.
