The water consumed times the sewer rate shall be the net amount of the sewer charges and shall be due and payable when the bill is rendered. The gross amount of the sewer bill shall be the net amount plus 10% of the net amount. The gross amount shall be due and payable if the net amount is not paid within 15 days of the date of the billing. If the gross amount of a sewer bill is not paid within 30 days of the date of the billing, the gross amount shall accrue interest at the rate of 1.1 per cent per month until date of payment.
