Regular Meeting of the Common Council of the City of Platts-burgh, New York, held January 3rd, 1941.

PRESENT: Mayor Bouyea, Aldermen Holland, O'Connell, Delaney, Golden, Behan and Tyrell.

By Alderman Behan; seconded by Alderman Tyrell:

LOCAL LAW NO. 3 of 1941.

ENTITLED AN ACT to amend Section 152 of the City Charter of the City of Plattsburgh, New York, being part of Chapter 269 of the Laws of 1902 of the State of New York, as amended by Chapter 583 of the Laws of 1915, and last amended by Local Law No. 3 of 1932, in relation to Notice of Receiving Taxes.

BE IT ENACTED by the Mayor and Common Council of the City of Plattsburgh, New York, that Section 152 of the City Charter as hereinabove mentioned, and as amended by Chapter 583 of the Laws of 1915, and as last amended by Local Law No. 3 of 1932, shall be superseded by the following:

Section 152. Notice of Receiving Taxes: Immediately on the delivery of the City Assessment Roll and warrant attached, to the Chamberlain for the collection of the amount specified in said warrant, the Chamberlain shall publish a notice once in the official newspapers of the City, that Chamberlain will attend at the Chamberlain's Office with said Assessment Roll and warrant, for thirty (30) days next after the publication of said notice, Bundays and legal holidays excepted, from nine o'clock in the morning to five o'clock in the afternoon daily, except Saturdays; and from nine o'clock in the morning to twelve o'clock noon on Saturday; except when the last day of the collection of one of the six payments falls on Saturday, then from nine o'clock in the morning to five o'clock in the afternoon, to receive the amount of the taxes specified in said warrant so assessed, and it shall be the Chamberlain's duty to attend accordingly. All taxes or assessments paid within thirty (30) days after the issuance of each warrant and the publication of the Chamberlain's notice, shall be payable without fee, percentage or interest thereon. On all taxes or assessments remaining umpaid after the expiration of sixty (60) days from such publication of the Chamberlain's notice of the receipt of the warrant by the Chamberlain, the Chamberlain shall collect interest at the rate of one percentum per month from the expiration of said sixty (60) days, which percentage and interest shall belong to the City.

This Local Law shall take effect immediately upon its approval.

On roll call, Aldermen Holland, O'Connell, Delaney, Golden, Behan and Tyrell voted in the affirmative; no one in the negative. CARRIED.
