A LOCAL LAW PROVIDING RATES AND REGULATIONS FOR THE USE OF PUBLIC AND PRIVATE SEWER AND DRAINS AND FOR THE LEVYING AND COLLECTION OF SEWER CHARGES:

BE IT ENACTED by the Mayor and Common Council of the City of Plattsburgh, New York as follows:

SECTION 1: The following are the rates and regulations for sewer services in the City of Plattsburgh.

SPECIAL PROVISIONS:

All those customers who do not have water meters installed in the water service line serving their premises on the effective date of this service classification shall be billed at the rate of \$31.50 per quarter until such time that a water meter has been set in the water service line to their premises. Thereafter, the rates for sewer service above set forth shall apply.

Bills may be rendered monthly at the option of the sewer department. Where bills are rendered on a monthly basis, one—third of the above quantities will be used in computing the charges for the various steps. The terms of payment, for monthly billings are net-fifteen d ys after date of bill. Gross amount shall be due thereafter.

SECTION 2: LAWS REPEALED.
