## LOCAL LAW NO.4 OF 1933.

ENTITLED AN ACT to amend Section 152 of the City Charter of Plattsburgh, N.Y., being part of Chapter 269 of the Laws of 1902 of the State of New York, as amended by Chapter 583 of the Laws of 1915 and as last amended by Local Law No. 3 of 1932, in relation to Notice of Receiving Taxes.

EE IT ENACTED by the Mayor and Common Council of the City of Plattsburgh, N.Y., that Section 152 of the City Charter as herein above-mentioned and as amended by Chapter 583 of the Laws of 1915 and as last amended by Local Law No. 3 of 1932, shall be superseded by the following:

SECTION 152: Notice of Receiving Taxes: Immediately on the delivery of the city assessment roll and warrant attached, to the Chamberlain for the collection of the amount specified in said warrant he (she) shall publish a notice once in the official newspapers of the City, that he (she) will attend at his (her) office with said assessment roll and warrant, for thirty (30) days next after the publication of said notice, Sundays and legal holidays excepted, from nine o'clock in the morning to four o'clock in the afternoon, and from seven o'clock post meridian until nine o'clock post meridian of each Saturday during said thirty days to receive the amount of taxes specified in said warrant so assessed, and it shall be his (her) duty to attend accordingly. All taxes or assessments paid within sixty (60) days after the issuance of the first warrant and the publication of the chamberlain's notice shall be payable without fee, percentage or interest thereon. On all taxes or assessments remaining unpaid after the expiration of such sixty (60) days, the Chamberlain shall collect one percentum additional, and on all remaining unpaid after the expiration of sixty (60) days from such publication of the Chamberlain's notice and receipt of warrant by him (her) for the collection of taxes for the first half, the chamberlain shall collect interest at the rate of one percentum per month from the expiration of said sixty (60) days, which percentage and interest shall belong to the City. The same procedure shall govern with respect with and to the collection of taxes for the second half with the exception that all taxes or assessments paid within thirty days of the chamberlain's notice shall be payable without fee, percentage or interest thereon. On all taxes or assessments remaining unpaid after the expiration of such thirty (30) days the Chamberlain shall collect one percentum additional, and on all remaining unpaid for the second half after the expiration of sixty (60) days from such publication of the Chamberlain's notice and receipt of warrant by him (her) for the collection of taxes due for the second half, the Chamberlain shall collect interest at the rate of one percentum per month from the expiration of said sixty (60) days, which percentage and interest shall belong to the City.

This Local Law shall take effect immediately upon approval.
