LOCAL LAW NO. 4 OF 1966

A LOCAL LAW AMENDING SECTION 141 OF CHAPTER 269 OF THE LAWS OF 1902, AS AMENDED BY LOCAL LAW NO. 40 OF 1949, IN THIS INSTANCE PRESCRIBING THE DUTIES AND FIXING THE COMPENSATION OF THE ACTING CITY JUDGE.

BE IT ENACTED BY THE MAYOR AND COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK.

SECTION 1. SECTION 141 OF CHAPTER 269 OF THE LAWS OF 1902, AS AMENDED BY LOCAL LAW No. 40 OF 1949, IS HEREBY AMENDED TO READ AS FOLLOWS:

ACTING CITY JUDGE, DESIGNATION OF, COMPENSATION. THE MAYOR SHALL DESIGNATE IN WRITING TO BE FILED WITH THE CITY CLERK, AN ATTORNEY AND COUNSELLOR-AT-LAW RESIDING WITHIN THE CITY OF PLATTSBURGH, WHO SHALL, DURING SICKNESS, ABSENCE FROM THE CITY, DISABILITY OR INABILITY OF THE CITY JUDGE TO ACT, EXERCISE IN THE PLACE AND STEAD OF THE CITY JUDGE ALL THE POWERS OF SAID JUDGE, INCLUDING JURISDICTION IN CASES PENDING THEN BEFORE THE SAID CITY JUDGE. IN SUCH CASES WHERE THE ACTING CITY JUDGE ACTS, IT SHALL BE UPON WRITTEN DIRECTION OF THE CITY JUDGE OR SUCH DIRECTION SHALL BE ENTERED IN THE COURT MINUTES PRIOR TO HIS ACTING. THE SALARY OF SAID ACTING CITY JUDGE SHALL BE THE SUM OF \$100.00 PER MONTH, PAYABLE MONTHLY, AND THE PROVISIONS OF THIS SECTION SHALL SUPERCEDE ANY LOCAL LAW ESTABLISHING THE PAY OF ACTING CITY JUDGE, AND ANY TIME LIMITATION WHICH MAY BE CONTAINED THEREIN RESPECTING WHEN HE MAY ACT.

SECTION 2. THIS ACT SHALL TAKE EFFECT AFTER PUBLIC HEARING AND APPROVAL BY THE MAYOR.

ON ROLL CALL, ALDERMEN BOOTH, KING, DUKEN, SABOURIN, COFFEY AND ROUGEAU VOTED IN THE AFFIRMATIVE; NO ONE IN THE NEGATIVE; CARRIED.
