The Mayor shall appoint a chairperson of the Planning Board from among the regular members. No member of the Common Council of the City of Plattsburgh shall be eligible for appointment to the Planning Board. Planning Board members whose terms expire in 1994 shall serve until December 31, 1994. Alternate members, members whose terms expire in 1994 or thereafter and who are reappointed, or their replacements, shall be appointed to a seven year term.
